Core Purpose:

The post holder will act as the Quality Nominee for BTEC provision, be the main point of contact for information related to quality assurance and will be involved in monitoring and supporting staff. The post holder shall, in consultation with the Headteacher, be responsible for:

- Ensuring there is an accredited Lead Internal Verifier in place for each principal subject area, where required
- Monitoring that assessment and internal verification is effective in all BTEC and vocational programmes
- Ensuring Standards Verification is completed successfully
- Confirming that the examination board's approval conditions and policy requirements are being implemented consistently and effectively.
- Providing effective support, challenge, information, and professional development for staff within the BTEC team as necessary.
- Establishing clear expectations and high standards of professionalism and collaboration across the team
- Providing structured support and assessment for NQT and trainees as required to enable them to meet the relevant professional standards
