

Job Title: Teaching Assistant (ALN) - Level 2

Overall Job Purpose:

As a registered professional practitioner with the Education Workforce Council, work under the instruction and guidance of teachers and/or members of the school leadership team to support individuals and groups of pupils to enable access to learning. Assist the teacher in the management of pupils within the classroom and beyond.

General: Comply with the local authority's Corporate Safeguarding Policy and the safeguarding duties and responsibilities which that policy places on every employee, aligning with the core values of the Authority which includes supporting children, adults who may be at risk and their families to keep them safe and healthy.

Main Duties / Responsibilities:

1. Supervise and provide particular support for pupils, including those with additional needs, ensuring their safety and access to learning activities.
2. Assist with the learning and development of all pupils, including the implementation of Individual Education/Behaviour Plans and Personal Care programmes including social, health/medical physical, Hygiene, first aid, toileting, feeding and mobility.
3. Following training, administer medication in accordance with the procedures for LEA and school policies.
4. Encourage pupils to interact with others and engage in activities led by the teacher.
5. Apply strategies to encourage independence and self-confidence and set challenging and demanding expectations and promote self esteem.
6. Provide feedback to pupils in relation to progress and achievement under guidance of the teacher.
7. Provide effective feedback to pupils in relation to programmes, and recognise and reward achievement.
8. Liaise with the teacher to create a purposeful, orderly and supportive learning environment.
9. Liaise with the teacher to share short-term planning and specific learning objectives for; identified groups, individuals, whole class.
10. Monitor pupils' responses to learning activities and undertake pupil record keeping as requested.
11. Establish routines to ensure regular and effective feedback is given to the teacher in respect of pupils' progress towards targets for learning and any difficulties.
12. Apply school policy in relation to the promotion of positive pupil behaviour and attitudes to learning.
13. Administer routine tests and invigilate exams.

14. Fulfil clerical and administrative tasks as required, e.g. photocopying, collecting money, filing, administer course work, distributing letters to parents.
15. Undertake structured and agreed learning activities/teaching programmes linked to local and national learning strategies, e.g. literacy, numeracy, early years, assessment for learning, ICT.
16. Support the use of ICT in learning activities and develop pupils' competence and independence in its use.
17. Prepare, maintain and use equipment/resources required to meet the lesson plans/relevant learning activity and assist pupils in their use.
18. Liaise sensitively and effectively with parents/carers as agreed with the teacher.
19. Participate in meetings with parents/carers and contribute to annual reviews in accordance with school practice.
20. Be aware and comply with policies and procedures relating to inclusion, child protection, health, safety and security, confidentiality and data protection, reporting all concerns to an appropriate person.
21. Contribute to the overall ethos/work/aims of the school, including Cwricwlwm Cymreig.
22. Attend and participate in relevant meetings as required, including weekly staff meetings.
23. Participate in training and other learning activities and professional assessment as required.
24. Assist with the supervision of pupils out of lesson times, including before and after school and at lunchtimes.
25. Accompany teaching staff and pupils on visits, trips and out-of-school activities as required and take responsibility for a group under the supervision of the teacher.
